### NOTICE OF PUBLIC HEARING

Notice is given that at **6:00 p.m. on Wednesday, November 19, 2025**, in the **City of Yuba City Council Chambers, 1201 Civic Center Boulevard, Yuba City, CA**, the Sutter County Planning Commission will hold a public hearing on the following:

**Project #U24-0035 (Chima)** – a resubmittal of a previously approved Tentative Subdivision Map (Project #U-18-010) to divide a  $10\pm$  acre parcel into five estate residential lots ranging from  $1.5\pm$  acres to  $2.7\pm$  acres and a Use Permit to reduce the agricultural buffer setback; ER (Estate Residential) District; located at 703 Barry Road, Yuba City, CA 95991; near the northeast corner of the intersection of Barry Road and Caminito Avenue; APN: 23-120-019; Applicant: Jay Chima, Owner: Tirath Chima. **(Previously Adopted Mitigated Negative Declaration)**

**Project #U25-0025 (Executive Homes)** – A Use Permit to allow for the replacement of an existing nonconforming mobile home on a  $1.71\pm$  acre parcel; EC (Employment Corridor) District; located at 4500 Sawtelle Avenue, Yuba City, CA 95991; located east of highway 99; APN 23-210-007 Applicant: Executive Homes, Owner: Harjit Kaur and Jasbir Singh Johal. **(Project is exempt from CEQA)**

**Project #U25-0028 (Sutter County)** – An amendment to Chapter 412 of the County Ordinance Code (Industrial Hemp Cultivation and Processing) in order to prohibit the cultivation of Industrial Hemp in the unincorporated area of Sutter County; Countywide; Applicant: Sutter County. **(Project is exempt from CEQA)**
