E-DATE'S have been used throughout this guide to indicate important dates and deadlines. These dates are the number of days prior to or after an election date. Example: E-88 means E minus 88 days and would be 88 days prior to an election, and E+28 means E plus 28 days and would be 28 days after an election. This type of date is often used in the Elections Code in order to avoid any variance from one election to the next. Refer to the Election Calendar for guidance as to what actual date the indicated E-Date falls on.

All candidate's filing information is considered public information and contact information may be posted on the Elections website.

ENFORCEMENT AGENCIES

Senate Members who were first elected to the State Legislature on or after the passage of Proposition 28 may serve 12 years in the Senate, or a combination of service in the Assembly and Senate if the combined terms do not exceed 12 years. However, Members elected to the State Assembly prior to the passage of Proposition 28 may serve a maximum of three two-year terms established by the passage of Proposition 140, in 1990. NEW CONFIDENTIAL VOTER STATUS

Assembly Bill (AB) 1392, effective **January 1st, 2026**, adds Election Code section 2166.9. This applies to all federal, state, or local elected officials as well as candidates. The residence address, telephone number, and email address appearing on an elected official or candidate's affidavit of voter registration is made confidential unless the individual opts out. Candidates can request to opt out when completing candidate filing forms. Please contact the Elections Office if you have any questions.

SIGNATURES IN LIEU OF FILING FEE PETITIONS

(EC 8105, 8106)

Signatures in Lieu of Filing Fee Petition

A candidate may submit a petition containing signatures of registered voters in Lieu of paying the filing fee. Signatures submitted may cover all, or a portion, of the filing fee. Any registered voter may sign a Signature in Lieu Petition for any candidate for whom he or she is eligible to vote. Petitions must be filed with the County Elections Official in the county where circulated no later than **February 4, 2026**. The County Elections Official will notify candidates of the number of valid signatures. The Signature in Lieu signatures are applied to the nomination signatures. The candidate can cover a deficiency of nomination signatures by submitting Nomination Documents prior to the close of nomination period. **All filing fees are non-refundable.**

Obtaining the Petition Form

Signature in Lieu petitions will be available from the County Elections Official beginning December 19, 2025. The form will be issued directly to the candidate or an authorized representative. There is no charge for the Signature in Lieu petition form and the candidate is responsible for duplicating as many copies as he/she needs. Duplicate the two pages **front to back** or staple single sided pages to ensure the two pages will not be separated. The County Elections Official maintains a list of persons who have applied for Signatures in Lieu Petitions. **This is considered public information** in the event of inquiries from the media or others.

Note: Candidates for voter-nominated offices may collect signatures from any registered voter within their district regardless of party registration.

SIGNATURES IN LIEU TOWARD NOMINATION SIGNATURES

(EC 8022, 8040-8041, 8061-8063, 8105-8106)

If a candidate submits a Signatures in Lieu Petition the County Elections Official shall also count those valid signatures appearing on the petition toward the number of voter signatures required for the candidate's Nomination Paper.

If a Signature in Lieu Petition does not contain the requisite number of valid signatures as set forth in Election Code 8062, the candidate shall be entitled to obtain nomination signatures within the time period allowed. A candidate who submits a Nomination Paper pursuant to this paragraph shall only be required to obtain the number of signatures thereon needed to supplement the Signature in Lieu Petition fee so that the combination of signatures appearing on the Signature in Lieu Petition fee and the Nomination Paper equals or exceeds the requisite number of signatures set forth in Election Code 8062.

GUIDELINES FOR GATHERING SIGNATURES

(EC 100, 102, 104, 106, 8065, 8066, 8068, 8106(b) (4))

Circulators (whether the candidate or another person) perform the important duty of obtaining signatures of properly registered voters for the Signatures in Lieu Petitions and/or Nomination Papers. If the signatures are not obtained properly and in accordance with the law, the candidate's right to be placed on the ballot could be jeopardized. Candidates should obtain the required number of signatures as soon as possible and return their petitions to the Elections Office for examination, filing or certification as required.

Petition Circulator Information

Anyone who is circulating a Signatures in Lieu Petition or Nomination Paper must be 18 years of age or older. A candidate for any office may obtain signatures and sign his/her own Nomination Petition or Signatures in Lieu Petition. His/her signature will be given the same effect as that of any other qualified signer. The circulator may circulate the petitions throughout the jurisdiction regardless of his/her county of residence.

Affidavit of Circulator

(EC104)

Each petition submitted shall have attached complete declaration; in his/her own hand:

- 1) Printed name of the circulator.
- 2) Residence address of the circulator, giving street and number, or if no street or number exists, adequate designation of residence so that the location may be readily ascertained.
- 3) Dates between which all the signatures to the petition or paper were obtained.

Each declaration submitted pursuant to this section shall also set forth the following:

- 1) That the circulator circulated that section and witnessed the signatures being written.
- 2) According to the best information and belief of the circulator, each signature is the genuine signature of the person whose name it purports to be. The circulator shall certify under penalty of perjury to the truth and correctness of the content of the declaration. The circulator shall state the date and the place of execution on the declaration immediately preceding his or her signature.
- 3) That the circulator is 18 years of age or older.
 - (b) The circulator shall certify the content of the declaration as to its truth and correctness, under penalty of perjury under the laws of the State of California, with the signature of his or her name. The circulator shall state the date and the place of execution on the declaration immediately preceding his or her signature.

Qualified Signers

Only a person who is a registered qualified voter at the time he/she signs the Nomination Petition or Signatures in Lieu Petition is entitled to sign it. At the time of signing the petition or paper each voter shall personally affix his or her signature, print his or her name and place of residence. Residence must indicate the street and number, and if no street or number exists, then a designation of the place of residence which will enable the location to be readily ascertained.

- Voter-nominated office Signatures in Lieu Petitions - Any registered voter within that jurisdiction regardless of party.
- Non-Partisan office Nomination Petitions – Any registered voter within that jurisdiction.

Voters May Sign Only One Paper Per Office

(EC 8069)

Signers may only sign one candidate's Nomination Paper per office unless the race has more than one seat to be filled. (i.e. If the office is a "Vote for Two" signers may sign up to two candidate's Nomination Papers)

Validation of Signatures

Secretary of State Guidelines

The following guidelines will be used when validating signatures on Nomination Petitions or Signatures in Lieu of filing fee Petitions.

A signature is **INVALID** if the signer:

- is not registered to vote;
- provides a signature on the petition that does not compare to the signature on the voter's affidavit of registration;
- does not reside in the appropriate district/county;
- uses a P.O. Box number for residence;
- uses a mail drop number for residence address;
- provides an address that is different from the voter's residence address on the affidavit of registration on record;
- prints his or her name for the signature, unless registered as such;
- lists her name as Mrs. John Jones;
- uses ditto marks for an address;
- authorizes Power of Attorney to sign on his or her behalf.

FILING FEES

(EC 8103 – 8105, 8106 (b))

When the filing fee is paid:

Candidates are required to pay the filing fee at the time they pick up their nomination forms. Candidates for Judicial Offices are required to pay the filing fee at the time they file their Declaration of Intention Form.

Where the filing fee is paid:

Pay the filing fee to the County Elections Official at the Sutter County Elections office.

Who the filing fee is paid to:

US Senate / State Senate / State Assembly / Congress: Checks are made payable to the "Secretary of State." The county will forward the fee to the Secretary of State.

County Offices / Superior Court Judge: Checks are made payable to "Sutter County Elections."

Amount of the filing fee:

The filing fee is a percentage of the annual salary for the office sought; refer to the 2026 Primary Filing Fee/Signature Requirement chart in this guide. No filing fee is required of offices with no fixed compensation or annual salary of \$2,500 or less. Write-in candidates are not required to pay filing fees.

Returned checks:

If the filing fee is paid with a personal check that is returned without payment, the County Elections Official will contact the candidate. The candidate must make payment by money order or cash by 5 p.m. on the next business day. Failure to do so will invalidate the individual's candidacy, **and the candidate's name will not appear on the ballot**. A returned check fee shall apply.

The filing fee is non-refundable.

DECLARATION OF INTENTION – JUDICIAL CANDIDATES

(EC 8023)

Candidates for Judicial Offices are required to file a Declaration of Intention and pay filing fees to become a candidate. No additional Signatures in Lieu Petitions may be filed after the Declaration of Intention has been filed.

The Declaration of Intention must be obtained from and filed with the County Elections Official of the county in which the candidate nomination papers are required to be filed and must be filed by the deadline.

NOMINATION PAPER

(EC 8020, 8041, 8062-8070)

All candidates must obtain Nomination signatures. The Nomination Petition must contain the minimum number valid signatures depending on the office sought. The petition shall be obtained and filed prior to filing the Declaration of Candidacy.

Deliver the Nomination Paper to the County Elections Official of the county in which the nomination papers are required to be filed.

Signers must be voters in the district or political subdivision in which the candidate is to be voted on and shall be affiliated with the party, if applicable, in which the nomination is proposed.

The County Elections Official will transmit to the Secretary of State the Nomination Document for each candidate for state office, United States Senator, Representative in Congress, and Member of the State Senate and State Assembly.

DECLARATION OF CANDIDACY

(EC 8020, 8023, 8028, 8101, 8105)

The Declaration of Candidacy is the official nomination document wherein the candidate (an incumbent or challenger) indicates how his/her name and ballot designation is to appear on the ballot. Additionally, the candidate declares that he/she meets the statutory and/or constitutional qualifications for the office sought and, if nominated, the candidate will accept the nomination and not withdraw.

The Oath of Office on the Declaration of Candidacy form must be taken and signed by the candidate before a person authorized to administer oaths. The county election official and public notaries are authorized administrators.

The candidate is required to execute the Declaration of Candidacy in the office of the county elections official unless a written statement is signed and dated by the candidate designating a person to receive the Declaration of Candidacy form from the county elections official and deliver it to the candidate. The written statement from the candidate includes language indicating that the candidate is aware that the Declaration of Candidacy must be properly executed and delivered to the county elections official in the county of the candidate's residence by the 88th day prior to the primary election or the 83rd day prior to the election if there is an extension to that office.

WITHDRAWAL OF CANDIDACY

(EC 8800-8811)

No candidate whose Declaration of Candidacy has been filed for any primary election may withdraw as a candidate at that primary election.

No candidate nominated at any primary election may withdraw as a candidate at the ensuing general election except those candidates permitted to withdraw by this part.

No vacancy on the ballot for a nonpartisan office at a general election shall be filled in the event of a candidate passing away and that fact has been ascertained by the officer charged with the duty of printing the ballots at least 68 days before the date of the next ensuing general election. EC 8808

BALLOT DESIGNATION

(EC 13107.3, 13107.5)

Ballot designation refers to the candidate's current occupation, vocation, profession, or incumbency status and appears below their name on the ballot. Candidates who wish to submit a ballot designation shall file a Ballot Designation Worksheet that supports the use of that designation by the candidate in a format prescribed by the Secretary of State. The ballot designation worksheet shall be filed with the Elections Official at the same time that the candidate files his/her Declaration of Candidacy. **If a candidate fails to or chooses not to file a ballot designation worksheet; no designation shall appear under the candidate's name on the ballot.** The word "None" will appear under the candidate's name if no Ballot Designation Worksheet is filed.

Regulations are defined on the Ballot Designation Worksheet.

Note: "Community Volunteer" as a ballot designation is subject to a candidate's community volunteer activities constitute his or her principal profession, vocation, or occupation; a candidate is not engaged concurrently in another principal profession, vocation, or occupation; and a candidate may not use the designation of "community volunteer" in combination with any other principal profession, vocation, or occupation designation. The Secretary of State shall by regulation define what constitutes a community volunteer for purposes of this section.

The Ballot Designation Worksheet is a public record and shall be available for inspection and copying at the Elections Office.

CANDIDATE'S STATEMENT OF QUALIFICATIONS

(EC 13307, 13308, 13311, 13313, 13314, 18351)

A statement by the candidate describing his/her education and qualifications is optional at the expense of the candidate for a nonpartisan elective office in any local agency and can be printed in the County Voters Information Pamphlet. The candidate statement and payment (estimated cost) must be submitted at the same time as the Declaration of Candidacy. If payment is made by check and the check does not clear the candidate's banking institution before the end of the County Voter Information Guide public display period (March 9, 2026), the candidate's statement **will not be printed in the County Voter Information Guide.**

The candidate's statement is designed to acquaint voters with a candidate's qualifications for the office he/she is seeking. The statement may include the name, age and occupation of the candidate and a brief description of no more than **200 words** (250 for Congressional candidates pursuant to EC 13307.5) of the candidate's education and qualifications. State Senate and Member of the Assembly candidates may file a **250-word** candidate statement in the County Voter Information Guide only if they have accepted the voluntary spending limits, Form 501, pursuant to Government Code 85601(c).

Statements should not contain any demonstrably false, slanderous, or libelous statements. The candidate is responsible for the content of the statement submitted for inclusion in the County Voter Information Guide. It is a misdemeanor for a candidate to knowingly make a false statement of a material fact in a candidate statement with intent to mislead voters in connection with his/her campaign for election to a nonpartisan office.

Time period for filing: The Statement of Qualifications must be filed with the Declaration of Candidacy.

Where: Sutter County Elections, 1435 Veterans Memorial Circle, Yuba City, CA

Format: Statement must be submitted as a Microsoft Word document on a USB drive.

Contents: The statement may contain the name, age and occupation of the candidate and a brief description of no more than 200 words (*unless otherwise stated*)

of the candidate's education and qualifications expressed by the candidate. The occupation listed in this location does not have the same restrictions as the ballot designation. The spacing for the statement is to be uniform and conform to the guidelines provided. Statements not in compliance with the formatting guidelines will be rejected or corrected by County Clerk.

Restrictions:

The candidate's statement shall not include the political party affiliation of the candidate nor membership or activity in partisan political organizations. Candidate photographs are not permitted.

Candidate statements should be about the candidate's own personal background and qualifications and shall not in any way refer to other candidates. The elections official shall not print or circulate any statement that the elections official determines does not meet this restriction. EC 13308

Withdrawal:

The statement may be withdrawn but not changed during the period for filing nomination papers and until 5:00 p.m. of the next business day after the close of the nomination period. Any request for withdrawal of a candidate's statement must be in writing and signed by the candidate.

EC 13307(a)(3)

Confidentiality:

Notwithstanding any other provisions of law, candidates' statements filed pursuant to EC 13307 shall remain confidential until the close of the nomination period for the office sought. EC 13311

Public Examination:

After the close of the nomination period, anyone may examine any candidate's statement and may purchase copies. During a 10-calendar-day period commencing the day after the close of the nomination period, any voter of the jurisdiction in which the election is being held, or the county elections official may seek a writ of mandate or an injunction requiring any or all of the material in a candidate's statement to be amended or deleted. EC 13313-13314

Cost:

An estimated printing cost is required when a candidate statement is filed. **Candidates will be billed for the difference if the actual cost exceeds the estimate and will receive a refund if the actual cost is less than the estimate.** The refund, if any, will be paid to the account the check was received from, so please keep your campaign account open after the election. EC 13307 (d)

PREPARATION OF THE CANDIDATE STATEMENT

(EC 13307)

The statement of each candidate shall be printed in uniform size, darkness, and spacing in standard paragraph format. The following guidelines are not permitted and will be removed if present:

1. Handwritten statements, circles, extra exclamation points, arrows, stars, dots, or bullets.
2. Use of any unusual spacing, underscoring or bolding on the statement.
3. Multiple indentations or multiple underscoring.

4. Use of all capital letters.
5. Use of any party affiliation for a nonpartisan office.
6. Inclusion of any membership or activity in partisan political organizations if filing for a nonpartisan office.

The California Elections Code prefers uniformity of appearance in the Candidates' Statements. By preparing your statement in accordance with the above guidelines, each statement will be uniformly printed and allowed the same amount of space in the Voter Information Pamphlet. **Statements will be type set exactly as submitted unless includes non-permissible items; candidates are, therefore, advised to carefully check their statements for errors in spelling, punctuation, and grammar.**

HOW TO COUNT WORDS

(EC 9, listed below)

Counting of words, for purposes of this code, shall be as follows:

- (1) Punctuation is not counted.
- (2) Each word shall be counted as one word except as specified in this section.
- (3) All proper nouns, including geographical names, shall be considered as one word; for example, "City of Yuba City or County of Sutter" shall be counted as one word.
- (4) Each abbreviation for a word, phrase, or expression shall be counted as one word.
- (5) Hyphenated words that appear in any generally available standard reference dictionary, published in the United States at any time within the 10 calendar years immediately preceding the election for which the words are counted, shall be considered as one word. Each part of all other hyphenated words shall be counted as a separate word.
- (6) Dates shall be counted as one word.
- (7) Any number consisting of a digit or digits shall be considered as one word. Any number which is spelled, such as "one," shall be considered as a separate word or words. "One" shall be counted as one word whereas "one hundred" shall be counted as two words. "100" shall be counted as one word.
- (8) Telephone numbers shall be counted as one word.
- (9) Internet Web site addresses shall be counted as one word.
- (b) This section shall not apply to counting words for ballot designations under Section 13107.

Note: It is department policy to count numbers consisting of a digit or digits used with a dollar sign (\$), cent sign (¢), percentage sign (%), or number sign (#) as one word.

Examples:

Abbreviations – (UCLA, U.C.L.A., USMC, U.S.M.C.) - one word
 Geographic Names – (County of Sutter, Yuba City) - one word
 Whole numbers - Digits - (1 or 10 or 100) - one word
 Spelled out numbers - (one hundred) – two words
 Numeric combinations - (1973, 18 1/2, 1971-73, 5%) - one word
 Monetary amounts - (if the dollar sign is used \$1) - one word
 Spelled out - (one thousand dollars) - one for each word
 Regularly hyphenated words if hyphenated in dictionary - one word

PLACEMENT OF CANDIDATE NAMES ON THE BALLOT

Random Alphabet Draw

(EC 13112)

The placement of names on the ballot is determined by a random alphabet draw which is held by the Secretary of State and Registrar of Voters on the 82nd day before the election. If more than one candidate has the same first letter of their last name, this draw applies throughout the name. County draws for State Senate and State Assembly, SOS to draw all other contests.

ELECTION DATA AVAILABLE FOR PURCHASE

All voter registration requests must be accompanied by a signed application and prepaid. Voter registration information is confidential pursuant to EC 2194. Misuse of this information is a misdemeanor pursuant to EC 18109. The individual signing the application is responsible for this data. Fees are subject to change; please contact the Elections Office for current fee.

ELECTIONEERING ON ELECTION DAY - 100 Feet Rule

(EC 18370)

No person on election day shall within 100 feet of a polling place, a satellite location, ballot drop box, curbside voting area, or an Election Official's office:

- Circulate an initiative, referendum, recall or nomination petition or any other petition
- Solicit a vote or speak to a voter about marking his ballot
- Place a sign relating to voters' qualifications or speak to a voter about his/her qualifications, except as provided in EC 14240
- Do any passive or active electioneering; this includes wearing buttons, T-shirts, stickers, etc. that promote a candidate or issue on the ballot

Any person who violates any of the provisions of this section is guilty of a misdemeanor.

ELECTIONEERING DURING VOTE BY MAIL VOTING

(EC 18371)

No candidate or representative of a candidate and no proponent, opponent or representative of a proponent or opponent of an initiative, referendum or recall measure or of a charter amendment, shall solicit the vote of a Vote by Mail voter, or do any electioneering, while in the residence or in the immediate presence of the voter, and during the time he or she knows the Vote by Mail voter is voting.

Any person who knowingly violates this section is guilty of a misdemeanor.

This section shall not be construed to conflict with any provision of the Federal Voting Rights Act of 1965 nor to preclude electioneering by mail or telephone or in public places, except as prohibited by Section 18370 or by any other provision of law.

MISREPRESENTATION BY CANDIDATES

(EC 18350)

Misleading Voters / Incumbency / Public Officer

Every person is guilty of a misdemeanor who, with intent to mislead the voters in connection with his/her

campaign for nomination or election to a public office or in connection with the campaign or another person for nomination or election to a public office, shall do either of the following acts:

- 1) Assume, pretend, or imply, by his/her statements or conduct, that he/she is the incumbent of a public office when that is not the case.
- 2) Assume, pretend, or imply, by his/her statements, conduct, or campaign that he/she has been acting in the capacity of a public officer when that is not the case.

Any violation of this section may be enjoined in a civil action brought by any candidate for the public office involved.

False Statements in Candidate Statements / Fines

Any candidate in an election or incumbent in a recall election who knowingly makes a false statement of a material fact in a candidate's statement prepared pursuant to EC 11327 or EC 13307, with the intent to mislead the voters in connection with his/her campaign for nomination or election to a nonpartisan office is punishable by a fine not to exceed \$1,000.

POLL WATCHERS

Poll Watchers at the polling place must obey the law and election procedures. People observing the polls may:

- Inspect, but not remove, the Roster of Voters, if used. Any such inspection must be conducted without impeding, interfering or interrupting the normal process of voting and counting.
- Inspect, but not remove, the Public's Alpha Index, if used, updated regularly by the precinct workers. The index may not be removed from the polling place.
- Observe all activities at the polling place, including activities after the polls close, providing they do not interfere with the normal processing of voters and election officer duties.

CORRUPTION OF VOTERS

(EC 18403, 18500, 18520 - 18524)

Fine For Solicitation Requesting Voter Disclosure of Ballot

Any person other than an elections official or a member of the precinct board who receives a voted ballot from a voter or who examines or solicits the voter to show his/her voted ballot is punishable by a fine not exceeding ten thousand dollars (\$10,000), by imprisonment in the state prison for 16 months or two or three years or in a county jail not exceeding one year, or by both the fine and imprisonment. This section shall not apply to persons returning a vote by mail ballot pursuant to EC 3017 and EC 3021 or persons assisting a voter pursuant to EC 14282.

Fraud In Connection with Votes Cast

Any person who commits fraud or attempts to commit fraud, and any person who aids or abets fraud or attempts to aid or abet fraud, in connection with any vote cast, to be cast, or attempted to be cast is guilty of a felony punishable by imprisonment for 16 months or two or three years.

Promise of Employment

A person shall not directly or through another person give, offer, or promise any office, place or employment or promise to procure or endeavor to procure any office, place or employment to or for any voter, or to or for any other person, in order to induce that voter at any election to:

- 1) Refrain from voting.
- 2) Vote for any particular person.
- 3) Refrain from voting for any particular person.

A violation of any of the provisions of this section shall be punishable by imprisonment in the state prison for 16 months or two or three years.

Consideration For Voting

A person cannot directly or through any other person receive, agree, or contract for, before, during or after an election, any money, gift, loan or other valuable consideration, office, place or employment for himself or any other person because he or any other person:

- 1) Voted, agreed to vote, refrained from voting or agreed to refrain from voting for any particular person or measure.
- 2) Remained away from the polls.
- 3) Refrained or agreed to refrain from voting.
- 4) Induced any other person to remain away from the polls, refrain from voting, and vote or refrain from voting for any particular person or measure.

Any person violating this section is punishable by imprisonment in the state prison for 16 months or two or three years.

Neither a person nor a controlled committee can directly or through any other person or controlled committee pay, lend, or contribute, or offer or promise to pay, lend, or contribute, any money or other valuable consideration to or for any voter or to or for any other person to:

Induce any voter to:

- 1) Refrain from voting at any election.
- 2) Vote or refrain from voting at an election for any particular person or measure.
- 3) Remain away from the polls at an election.

Reward any voter for having:

- 1) Refrained from voting.
- 2) Voted for any particular person or measure.
- 3) Refrained from voting for any particular person or measure.
- 4) Remained away from the polls at an election.

Any person or candidate violating this section is punishable by imprisonment in the state prison for 16 months or two or three years.

Bribery At Election

A person cannot directly or through any other person advance or pay, or cause to be paid, any money or other valuable thing to or for the use of any other person, with the intent that it, or any part thereof, shall be used in bribery at any election, or knowingly pay or cause to be paid any money or other valuable thing to any person in discharge or repayment of any money, wholly or in part, expended in bribery at any election.

Any person violating this section is punishable by imprisonment in the state prison for 16 months or two or three years.

Payment For Securing Vote

A person cannot directly or through any other person advance or pay, or cause to be paid, any money or other valuable thing to or for the use of any other person, with the intent that it, or any part thereof, will be used for boarding, lodging, or maintaining a person at any place or domicile in any election precinct, ward, or district, with intent to secure the vote of that person or to induce that person to vote for any particular person or measure. Any person violating this section is punishable by imprisonment in the state prison for 16 months or two or three years.

INTIMIDATION OF VOTERS

(EC 18540 - 18543)

Compelling Another in Voting

Every person who makes use of, hires or arranges for any other person to make use of, or threatens to make use of any force, violence, or tactic of coercion or intimidation, to induce or compel any other person to vote or refrain from voting at any election or to vote or refrain from voting for any particular person or measure at any election, or because any person voted or refrained from voting at any election or voted or refrained from voting for any particular person or measure at any election is guilty of a felony punishable by imprisonment in the state prison for up to 16 months or 2-3 years. This section applies to in person voting,

satellite offices, election office, Vote by Mail voting, and drop boxes.

No person shall, with the intent of dissuading another person from voting, within 100 feet of a polling place, do any of the following:

- 1) Solicit a vote or speak to a voter on the subject of marking his or her ballot.
- 2) Place a sign relating to voters' qualifications or speak to a voter on the subject of his or her qualifications except as provided in Section 14240 .
- 3) Photograph, video record, or otherwise record a voter entering or exiting a polling place.

Any violation of this section is punishable by imprisonment in a county jail for not more than 12 months, or in the state prison. Any person who conspires to violate this section is guilty of a felony.

For purposes of this section, 100 feet means a distance of 100 feet from the room or rooms in which voters are signing the roster and casting ballots.

STATEMENT OF ECONOMIC INTERESTS

(FORM 700)

(GC 87200 – 87203, 87500, 81008)

State offices, County offices and Superior Court Judge candidates must file statements of economic interests disclosing their investments, interests in real property, and any income received during the preceding 12 months at the time of filing the Declaration of Candidacy with the local filing official during the nomination period. Statements of Economic Interest are public record.

Exception: The statement is not required if the candidate has filed such a statement within the past 60 days for the same jurisdiction.

NEW: Judges, County Treasurer, and Board of Supervisors must file electronically directly with FPPC. Candidates can obtain their log in and password information by emailing form700@fppc.ca.gov.

SIGN REGULATIONS

STATE OUTDOOR ADVERTISING ACT

Section 5405.3

The Department of Transportation, Division of Traffic Operations, Outdoor Advertising Program requires candidates to file a Statement of Responsibility certifying a person who will be responsible for the campaign's signs. State sign requirements include that signs cannot be placed 90 days prior to the election and must be removed within 10 days after the election, or the party responsible will be billed for any associated removal costs. A Statement of Responsibility and letter will be provided to the candidate during the filing process.

POLITICAL SIGNS: SUTTER COUNTY PROHIBITED SIGN ZONING CODE 1500-9430

The following signs are expressly prohibited:

- A. Portable, A-frame, banners, inflatable displays, flying signs, searchlights and similar except as provided.
- B. Signs that include any part that appears to flash, blink, move, change color, or change intensity, excluding flags and pennants, standard barber poles, and date, time and temperature signs.
- C. Signs that emit noise, odor or any visible matter other than light.
- D. Roof signs and any signs that projects above the building wall or parapet to which they are affixed.

- E. Signs that obstruct a door, window, fire escape, or other required building access way.
- F. Pole signs.
- G. Signs that encroach into any public right-of-way or easement, means of ingress or egress, or path of travel.
- H. Signs that interfere with visibility and/or restrict safe sight distances for drivers at any intersection, public or private road, or driveway.
- I. Freestanding signs within the corner lot clear vision triangle.
- J. Signs adversely affecting traffic control or safety.
- K. Signs located on public property, excluding official signs that are posted or required by a government agency, public utility, or public service.
- L. Off-site advertising signs, including billboards, except as otherwise provided.
- M. Signs on vehicles, trailers, boats, storage boxes or other similar objects where such signs are not incidental to the primary use of the vehicle or other similar object, and where the primary purpose of the sign and vehicle or other similar object upon which the sign is attached is for advertising purposes.
- N. Signs that have become a public nuisance due to inadequate maintenance, dilapidation, or abandonment.
- O. Signs that were unlawfully installed, erected, or maintained.
- P. Signs that have less clearance from overhead lines and other utilities than required by the applicable service providers.

The Secretary of State's Political Reform Division administers provisions of California's Political Reform Act of 1974 that requires the disclosure of financial activities related to political campaigns and lobbying. Specific activities of the Political Reform Division include:

- register and issue identification numbers for all state and local campaign committees that raise funds in connection with elections (non-federal) throughout California
- receive notices from all state and local candidates of their intentions to raise campaign funds and establish separate bank accounts for these funds
- receive campaign disclosure statements (itemizing contributions received and expenditures made) filed by individuals and committees raising or spending campaign funds to support or oppose state candidates or ballot measures
- provide technical assistance regarding campaign disclosure provisions of the Political Reform Act to state and local candidates and elected officials, treasurers of campaign committees and the public
- review state campaign documents to ensure compliance with reporting requirements
- provide public access to all campaign disclosure documents
- publish campaign financing reports that summarize and analyze the extensive information contained in campaign documents filed with the Political Reform Division
