NOTICE OF PUBLIC HEARING

Notice is given that at **6:00 p.m. on Wednesday, February 18, 2026**, in the **City of Yuba City Council Chambers, 1201 Civic Center Boulevard, Yuba City, CA**, the Sutter County Planning Commission will hold a public hearing on the following:

Project #U25-0020 (Takher) – Tentative Parcel Map to divide an existing 27.9± acre parcel into a 2.4± acre homesite parcel and a 25.5± acre remainder parcel; AG (Agriculture) District; located at the southwest corner of Taylor Road and Holcomb Avenue, Yuba City, CA 95993; APN: 23-030-107; Applicant/Owner: Harminder Takher. (**A Mitigated Negative Declaration is proposed**)

Project #U25-0031 (Lennar) – Use Permit to allow the development of a 5,063± square foot sales/work and play center on the northern portion of Lot C of the Large Lot Final Map of Lakeside at Sutter Pointe Phase 1 to support the Latitude Margaritaville development within the Sutter Pointe Specific Plan (SPSP) area. The project also includes a Use Permit to allow off-site parking to be located on Lot 3; located approximately 0.7 miles north of Riego Road and 0.6 miles west of Natomas Road; APNs: 36-010-010 & 36-010-009; Applicant: Lennar Homes of California, LLC; Owner: DRP Greenbough 34 LLC (**Addendum to the previously certified Sutter Pointe Specific Plan Environmental Impact Report**)

Project #U26-0004 (L Street Land LP) – A second amendment to the Tier 2 Development Agreement relative to the Lakeside Development of the Sutter Pointe Specific Plan to revise Sections 3.4, 3.5, 3.10, and 4.2; located north of Riego Road and west of Natomas Road; Applicant/Owner: L Street Land LP, DRP Greenbough 34 LLC, and DRP Solaris Multistate LLC; Assessor's Parcel No. 36-010-001 thru -015 and 36-020-001 thru -012.
